CHARTER SERIES**

AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER, LOUISIANA TO APPROVE AND ADOPT THE TITLE VI FEDERAL TRANSIT ADMINISTRATION NON-DISCRIMINATION PROGRAM BY THE LOUISIANA DEPARTMENT OF TRANSPORTATION, AND REPEALING ALL ORDINANCES AND PARTS OR ORDINANCES IN CONFLICT HEREWITH.

WHEREAS, the City of DeRidder, Louisiana (“City”) is responsible for providing safe, dependable and economical transportation service to its patrons; and

WHEREAS, the City, as an operating demand response transit provider, and recipient of Federal Transit Administration (FTA) grant dollars either directly from the FTA or through the Louisiana Department of Transportation and Development (LADOTD), is to be compliant with Title VI of the Civil Rights Act of 1964 and the Civil Rights Restoration Act of 1987; and

WHEREAS, the City Council of the City of DeRidder finds that it is in City’s best interest that City adopt the Title VI Federal Transit Administration Non-Discrimination Program by the Louisiana Department of Transportation as attached hereto as Exhibit “A”:


NOW, THEREFORE, BE IT ORDAINED that the Title VI Federal Transit Administration Non-Discrimination Program by the Louisiana Department of Transportation constituting Exhibit “A” hereto be, and the same is hereby, approved and adopted for the City of DeRidder.

BE IT FURTHER ORDAINED that the Mayor of the City of DeRidder be, and she is hereby, authorized to sign any and all documents necessary for implementation of said program and signifying her authority for same.


BE IT FURTHER ORDAINED that all ordinances and parts of ordinances in conflict herewith be, and the same are hereby, repealed.







Policy Statement

The **City of DeRidder/Beauregard Transit** assures that no person shall on the grounds of race, color, or national origin as provided by Title VI of the Civil Rights Act of 1964, and the Civil Rights Restoration Act of 1987 (P.L. 100.259) be excluded from participation in, be denied the benefits of, or be otherwise subjected to discrimination under any programs or activities. The **City of DeRidder/Beauregard Transit** assures every effort will be made to ensure nondiscrimination in all of its programs and activities, whether those programs and activities are federally funded or not (inclusive of additional Title VI Authorities and citations).

The Civil Rights Restoration Act of 1987, broadened the scope of Title VI coverage by expanding the definition of terms “programs or activities” to include all programs or activities of Federal Aid recipients, sub-recipients, and contractor/consultants, whether such programs and activities are federally assisted or not (Public Law 100259 [S.557] March 22, 1988.)

The **City of DeRidder/Beauregard Transit** Non-Discrimination Complaint Procedure is made available in the following locations:

Any individual, group of individuals or entity that believes they have been discriminated against on the basis of race, color, national origin or disability by the **City of DeRidder/Beauregard Transit** may file a non-discrimination complaint by completing and submitting the agency's non-discrimination Complaint Form. File initial complaint with Allison Hanchey at **City of DeRidder/Beauregard Transit**.

Any individual having filed a complaint or participated in the investigation of a complaint shall not be subjected to any form of intimidation or retaliation. Individuals who have cause to think that they have been subjected to intimidation or retaliation can file a complaint of retaliation following the same procedure for filing a discrimination complaint.

A complaint must be filed with the **City of DeRidder/Beauregard Transit** no later than 180 days after the following:

1. The date of the alleged act of discrimination; or
2. The date when the person(s) became aware of the alleged discrimination; or
3. Where there has been a continuing course of conduct, the date on which that conduct was discontinued of the latest instance of the conduct.

Once the complaint is received, the **City of DeRidder/Beauregard Transit** will review it to determine if our office has jurisdiction. (A copy of each non-discrimination complaint received will be forwarded to the Louisiana Department of Transportation and Development within ten (10) calendar days of receipt.) The complainant will receive an acknowledgement letter informing her/him whether the complaint will be investigated by our office.

The **City of DeRidder/Beauregard Transit** has 45 days to investigate the complaint. If more information is needed to resolve the case, the **City of DeRidder/Beauregard Transit** may contact the complainant.

After the investigator reviews the complaint, she/he will issue one of two (2) letters to the complainant: a closure letter or a letter of finding (LOF).

- ✓ A closure letter summarizes the allegations and states that there was not a Title VI or other discriminatory violation and that the case will be closed.
- ✓ A letter of finding (LOF) summarizes the allegations and the interviews regarding the alleged incident, and explains whether any disciplinary action, additional training of the staff member, or other action will occur.

If the complainant wishes to appeal the decision, she/he has 180 days after the date of the letter or the letter of finding to do so. A person may also file a complaint directly with the: Louisiana Department of Transportation, Attn: Cynthia Douglas, 1201 Capitol Access Road, Baton Rouge, LA 70804.

LADOTD will analyze the facts of the case and will issue its conclusion to the appellant within 60 days of the receipt of the appeal.

Cualquier individuo que haya presentado o participado en la investigación de alguna queja no debe ser sujeto a ninguna forma de intimidación o represalia. Aquel individuo que considere que haya sido sujeto a intimidación o represalias puede llenar un formulario de queja para represalias siguiendo este mismo procedimiento.

Esta queja deberá ser presentada a la Oficina de Programas de Cumplimiento del City of DeRidder/Beauregard Transit en un periodo de no mas de 180 días después de lo siguiente:

1. La fecha del presunto acto de discriminacion
2. La fecha en la que la persona (s) se percataron del presunto acto de discriminacion
3. Cuando se ha detectado que el acto de discriminacion se ha convertido en una conducta repetitiva. En estos casos se incluiria la fecha del último acontecimiento.

Una vez que se reciba la queja, la oficina de City of DeRidder/Beauregard Transit lo revisará para determinar si nuestra oficina tiene jurisdicción. El demandante recibirá una carta de notificación comunicando si la queja será investigada por nuestra oficina.

El/La coordinadora de la oficina de City of DeRidder/Beauregard Transit tendrá 45 días para investigar la queja. Si se necesita mas información para resolver el caso, el (la) Coordinador (a) podría contactar al demandante.

Después de que el (la) Coordinador revise la queja, emitirá una de dos (2) cartas al demandante

- Una carta de cierre resumiendo las alegaciones del caso en la cual indicara que no hubo una violacion de discriminación y por tal motivo el caso sera cerrado.
- Una carta de hallazgo resumiendo las alegaciones y las entrevistas sobre el supuesto incidente en esta misma carta se le explicara al demandante si se llevara a cabo alguna acción disciplinaria, entrenamiento adicional al personal o se tomara alguna otra acción necesaria.

Si el demandante desea apelar la decisión, el tendrá 180 días después de la fecha marcada en la carta de cierre o de la carta de hallazgo para hacerlo. El (La) Coordinador, Cynthia Douglas (225) 379-192

Titulo VI I ADA analizara los hechos del caso y emitirá su conclusión al apelante en un periodo de 60 días después de haber recibido la apelación.

- Item #5: A description of how employees are trained to provide language assistance to LEP persons

Four Factor Analysis Methodology

To determine if an individual is entitled to language assistance and what specific services are appropriate, the City of DeRidder/Beauregard Transit has conducted a *Four Factor Analysis* of the following areas: 1) LEP Demography, 2) Contact Frequency, 3) Importance of Service, and 4) Resources and Costs.

Factor 1: The number or proportion of LEP persons eligible to be served or likely to be encountered by the program or recipient. In addition to the number or proportion of LEP persons served, the City of DeRidder/Beauregard Transit will identify:

- (a) How LEP persons interact with the recipient's agency;
- (b) Identification of LEP communities, and assessing the number or proportion of LEP persons from each language group to determine the appropriate language services for each language;
- (c) The literacy skills of LEP populations in their native languages, in order to determine whether translation of documents will be an effective practice; and
- (d) Whether LEP persons are underserved by the recipient due to language barriers.

Factor 2: The frequency with which LEP persons come into contact with the program. Identifies and assesses the frequency City of DeRidder/Beauregard Transit's staff comes into contact with LEP persons. Examples of contact could include:

- (a) Use of bus and rail service;
- (b) Purchase of tickets through vending machines, outlets, websites, and over the phone;
- (c) Participation in public meetings;

- (d) Customer service interactions;
- (e) Ridership surveys;
- (f) Operator surveys.

Factor 3: The nature and importance of the program, activity, or service provided by the program to people’s lives. Generally speaking, the more important the program, the more frequent the contact and the likelihood that language services will be needed.

This section discusses how the City of DeRidder/Beauregard Transit’s program and services impact the lives of person’s within the community. The City of DeRidder/Beauregard Transit will specify the community organizations that serve LEP persons, if available.

Factor 4: The resources available to the recipient for LEP outreach, as well as the costs associated with that outreach. Resource and cost issues can often be reduced by technological advances, reasonable business practices, and the sharing of language assistance materials and services among and between recipients, advocacy groups, LEP populations and Federal agencies. Large entities and those entities serving a significant number of LEP persons should ensure that their resource limitations are well substantiated before using this factor as a reason to limit language assistance.

The summary below discusses the low cost methods the City of DeRidder/Beauregard Transit use to provide outreach to LEP persons as well as train staff (and transit provider/lessee, if applicable) on Title VI and LEP principles.

Item #1 – Results of the Four Factor Analysis (including a description of the LEP population(s) served)

Factor 1: The number or proportion of LEP persons eligible to be served or likely to be encountered.

The City of DeRidder/Beauregard Transit staff reviewed the American Community Survey data <https://www.census.gov/programs-surveys/acs> and determined that 1,735 (5.1 %) of the persons in the **Beauregard Parish** speak a language other than English. In **Beauregard Parish**, of the 1,735 (5.1 %) of persons with limited English proficiency, 882 (2.6 %) speak Spanish.

Factor 2: The frequency with which LEP persons come into contact with the program.

The City of DeRidder/Beauregard Transit assessed the frequency with which staff and drivers have, or could have, contact with LEP persons. The City of DeRidder/Beauregard Transit provides approximately 6,349 passenger trips per year. If an individual has speech limitations, the dispatcher or driver will work with the Transit Manager and the LADOTD, if needed, to ensure the individual receives access to the transit services.

Factor 3: The nature and importance of the program, activity, or service provided by the program to people’s lives.

All of The City of DeRidder/Beauregard Transit programs are important; however, those related to safety, public transit, nondiscrimination and public involvement are among the most important. The City of DeRidder/Beauregard Transit is committed to providing meaningful access and will provide written translation for any of its documents, when reasonable, effective and with the available resources. In other cases, the City of DeRidder/Beauregard Transit will strive to provide alternative but meaningfully accessibility. Moreover, the City of DeRidder/Beauregard Transit continually evaluates its programs, services, and activities to ensure that persons who may be LEP are always provided with meaningful access. The Title VI policy, complaint form, and LEP policy are available in Spanish upon request.

Factor 4: The resources available for LEP outreach, as well as the costs associated with that outreach.

The City of DeRidder/Beauregard Transit makes every effort to make its programs, services, and activities, accessible to LEP individuals. The City of DeRidder/Beauregard Transit will use available resources, both internal and external to accommodate reasonable requests for translations.

Item # 2 – Description of how Language Assistance Services are Provided, by Language

The City of DeRidder/Beauregard Transit has identified, developed, and uses the following:

- a) Individuals who have contact with the public are provided with “I Speak” language cards to identify language needs in order to match them with available services. Language cards verified and distributed by the Director as need.
- b) The City of DeRidder/Beauregard Transit has developed partnerships with local agencies, organizations, law enforcement, colleges/universities, local school districts and social service agencies that are available to assist with it LEP responsibilities.
- c) A list of web based translation services can be provided by contracting the Human Resources Department.

Item # 3 - Description of how LEP Persons are Informed of the Availability of Language Assistance Service

In order to ensure that LEP individuals are aware of City of DeRidder/Beauregard Transit’s language assistance measures, City of DeRidder/Beauregard Transit provides the following:

- Title VI Program including the Language Assistance Plan is made available on website, if applicable, and hard copy in central office.
- Drivers and dispatchers are provided “I Speak” language cards to identify language needs in order to match them with available services.

Item # 4 – Description of how the Language Assistance Plan is Monitored and Updated

The City of DeRidder/Beauregard Transit will continue to update the LEP plan as required by U.S. DOT. At a minimum, the plan will continue to be reviewed and updated every three (3) years in conjunction with the Title VI submission, or when data from the 2020 U.S. Census is available, or when it is clear that the concentrations of LEP individuals are present in the City of DeRidder/Beauregard Transit service area. Updates will continue to include the following:

- The number of documented LEP person contacts encountered annually.
- How the needs of LEP persons have been addressed.
- Determination of the current LEP population in the service area.
- Determination as to whether the need for translation services has changed.
- Determine whether local language assistance programs have been effective and sufficient to meet the need.
- Determine whether City of DeRidder/Beauregard Transit financial resources are sufficient to fund language assistance resources needed.
- Determine whether City of DeRidder/Beauregard Transit has fully complied with the goals of this LEP Plan.
- Determine whether complaints have been received concerning City of DeRidder/Beauregard Transit failure to meet the needs of LEP individuals

Item # 5 - Description of how Employees are Trained to Provide Language Assistance to LEP Persons

The following training will continue to be provided to The City of DeRidder/Beauregard Transit staff:

- Information on the City of DeRidder/Beauregard Transit Title VI Procedures and LEP responsibilities.
- Description of language assistance services offered to the public.
- Use of “I Speak” languagecards (used to identify language preference).
- Documentation of language assistance requests.
- Use of web-based interpreter services (337-462-8911)
- How to handle a potential Title VI / LEP complaint.
