What do I bring?

Photo ID
 Social Security card or Individual Taxpayer Identification Number (ITIN) (card or letter for yourself and each person to be claimed on your tax return)
 Birth dates for every person to be claimed on your tax return
 W2 or 1099 forms for all jobs held in 2009
 End of the year statements for other income you received (including bank interest, social security income, unemployment, etc.)
 End of the year retirement plan statements (401 (k), IRA, etc.)
 Child care provider name, address and tax ID number
 Record of expenses (child care, education, medical, dental, etc.)
 For a faster refund, a blank check with your account number and bank routing number

Who Qualifies?

Who Qualifies for FREE tax help? Anyone whose 2009 income was less than \$48,000 and is a U. S. Citizen or Legal Permanent resident.

Does the State of Louisiana offer EITC? Yes, the State EITC is 3.5% of the Federal EITC
