 1. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER THROUGH ITS MAYOR TO ENTER INTO A HIGHWAY MAINTENANCE AGREEMENT, INCLUDING MOWING AND LITTER PICKUP, WITH THE STATE OF LOUISIANA THROUGH THE DEPARTMENT OF TRANSPORTATION AND DEVELOPMENT, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
 2. AN ORDINANCE AUTHORIZING THE CITY OF DERIDDER THROUGH ITS MAYOR TO ENTER INTO A CONTRACT WITH ALLIED RESTORATION & CONSTRUCTION FOR THE PURPOSE OF

REMOVING AND REPLACING THE DAMAGED EXTERIOR INSULATION AND FINISH SYSTEMS (EFIS) ON THE BRICK FACADE OF THE ENTRYWAY TO CITY HALL, THE POLICE STATION AND THE SOUTH ENTRYWAY TO THE POLICE STATION, RESULTING FROM DAMAGES CAUSED BY HURRICANE LAURA, AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.
