 1. AN ORDINANCE AUTHORIZING A REZONING OF PROPERTY LOCATED AT 1412 ROSE STREET AND IDENTIFIED BY BEAUREGARD PARISH TAX ASSESSOR PARCEL NUMBER 0333022856 IN DERIDDER, LOUISIANA, AND BEING MORE FULLY DESCRIBED IN THE BODY OF THIS ORDINANCE, SAID PROPERTY BEING PRESENTLY ZONED B-3 (GENERAL BUSINESS DISTRICT) TO BE REZONED B-1 (TRANSITIONAL BUSINESS DISTRICT), AS REQUESTED BY ARYN CLOUSE; AND REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH.

2.
